Hannah, her husband, Joe, and their three sons operate Healthy Harvest Organics (a pasture-raised poultry farm) in Grafton in Lorain County. They serve the community through direct-to-consumer sales, as well as educational events.

Hannah is committed to working with and for us - the grassroots of the organization, "together, we can build a future that honors our agricultural heritage while paving the way for innovative ag growth."

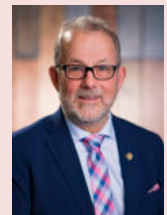

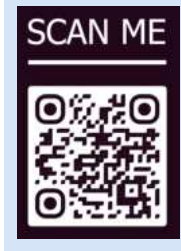
